Questions regarding the future of St. Mary Medical Center were raised by our members, mimicking those in all quarters of our host city. Would the medical center be sold? Would it become a for-profit hospital? Was a new cash-rich partner in the wings? Some questions were justifiable and well-reasoned. Others were responding to rumor, innuendo, speculation, and good old-fashioned guessing. No one knew the answers.

Now we know.

St. Mary Medical Center will remain just what it has been since its founding almost 90 years ago – a non-profit medical center with strong historical and philosophical ties to the community and the Catholic Church, anchored by the caring mission of the Sisters of Charity of the Incarnate Word. It remains an integral part of one of the largest, non-profit hospital groups in America. Our Foundation continues as it has been for 41 years, a loyal, enthusiastic, and exclusive financial supporter of St. Mary Medical Center and its services.

We have emerged from this period, of course, relieved that St. Mary Medical Center has weathered the storm and that the Foundation’s mission continues. Yet, just

considering what we might have lost, we have come away with more. Today, we have an even greater appreciation of the people and programs of St. Mary, services and facilities that could have been throttled back or sacrificed had a different path been chosen.

Since a number of months always pass between the end of the fiscal year (June 30) and the publication of the Foundation’s Annual Report that must await the compilation of facts and figures from many sources, I felt this note was needed to assure our donors and friends that all is well. Yet, change will undoubtedly continue. In fact, as I draft this note in January 2012, the announcement has just been made that CHW, the medical center’s corporate parent, has changed its name to Dignity Health, effective immediately. And, so it goes.

Despite change and challenge, 2010-2011 was a highly successful year for our Foundation, and all who were responsible for it have my sincere congratulations and deserve the accolades of the community they served so well.

Message from the Chair

There are periods in every life when the underpinning of who we are, what we do and what we know suddenly is shaken to the core. What was for so long may not be much longer. What we have worked to sustain may soon be unnecessary. What we have taken for granted over a lifetime may be altered by forces we cannot control. Nothing, as they say, lasts forever.

Well, perhaps some things do.

We began our 2010-2011 fiscal year in the middle of a 40th Anniversary Foundation capital campaign for technological and facility support projects in cardiology, women's health, obstetrics and bariatric care and to raise funds for mission-based programs begun by the Sisters over the years.

Such human needs are always with us.

At the time we began the 2010-2011 year, we already had \$758,000 toward our \$1.25 million goal. Under the always able leadership of Lou Cassani, my predecessor as Foundation chair, the campaign goal was quickly eclipsed in less than nine months. We were grateful to receive gifts from newer benefactors but also thank the generous donors who have been with us – every step of the way – since the Foundation began forty years ago, a fitting conclusion to a 40th Anniversary fund drive.

The generosity of the Greater Long Beach community is unshakable.

By November 2010, the efforts to convince some people and organizations to donate items of significant value and to entice others to pay even more than they might be worth, bore fruit as our 30th Annual Gala Auction saw 560 people bid on 500 items, bringing in a total of \$327,000 net for the evening.

In the case of both the 40th Anniversary capital campaign and the 30th Annual Gala Auction, individual gifts of \$5,000 or more were matched by a series of \$5,000 “matching grants” through the

generosity of the Ackerman family and the Evalyn M. Bauer Foundation, continuing the unprecedented, multi-million-dollar generosity that began when Modestus and Evalyn Bauer first stepped forward more than forty years ago.

The ability of individuals to change our world is as old as mankind itself.

During the year, the recommendations made in 2010 by an outside consultant for the Foundation to refocus on volunteers, board leadership and staff was brought to fruition and we increased our concentration on major gifts and planned giving, and recruited new Board members. With the anticipated retirement of Foundation President, John Wagner, after 20 years of outstanding service to the Foundation and the community, Drew Gagner, a seasoned, fund development executive with nationwide experience in major medical centers on the East and West Coasts, was named his successor. We also saw the retirement of our Vice President, Ike Hancock and the departure of our Director of Development, Denice Lanuti, for a new professional opportunity.

New faces, like new opportunities, are inescapable and bring exciting new challenges.

Our 19th Annual Charity Golf tournament, the final event of every fiscal year, had become a veritable institution under the 18-year leadership of Dr. Vince Esposito and had raised \$2.6 million over the years. This year, Paul Carter and Dr. Steve Shea co-chaired the June event with a full field of 144 golfers spending a great day on the links at the Virginia Country Club and raising \$190,000 to support Labor, Delivery and Pediatrics at St. Mary.

As we brought this year to a close, there arose a matter of concern to the Foundation, to those affiliated with it, and to the community

at large. By June 30, 2011, there were reports that St. Mary Medical Center would undergo major changes that, if true, could significantly impact our Foundation's mission and operations. We concluded the year unsure of the future. To ignore those reports and their potential impact for 2011-2012 and beyond would be a disservice to our history.

However, by all traditional measures, 2010-2011 was a successful year on all fronts. Despite our questions and concerns about the future of the medical center and our Foundation, we ended the year with an unflinching belief in the goodness of our Sisters, the life-preserving dedication of the people at St. Mary Medical Center, the loyalty of the volunteers within our own Foundation, and in the caring of the thousands of folks in and around Long Beach who have sustained the good works of St. Mary throughout our community for almost 90 years.

Some things – vital, life-affirming things – really do last forever. Thanks for a wonderful term.

Commitment to Community

St. Mary Medical Center has had a close bond with the Long Beach community for 89 years. When the Sisters were invited to minister to the sick, they purchased the hospital from Dr. Boyd. It was in this small frame building in 1923 that a new service to the community of Long Beach began. When the Sisters purchased the hospital, it was with a vision to respond not only to a need but also to embark on a mission of building a medical center that was to become a leading enterprise in the provision of health care.

Of course, the growth of a medical center was no small task but one built on steps of confidence and a milestone that was carefully and quietly executed through philanthropic endeavors. The community came together to ensure that the Sisters saw their vision become a reality in a spiritual, healing environment.

The transformation from the original small building was not without its challenges, the first of which was the earthquake of 1933 which caused severe damage but fortunately no loss of life. It was in this darkest hour, post-earthquake, that the community rallied to support the Sisters who maintained their commitment to continue providing medical service. This reconstruction effort was indeed a partnership – a coming together of Sisters and the community, committed to bringing about a new, updated, state of the art medical complex that continued to grow and expand. With the rebirth of the city after the earthquake, the Sisters never wavered in their dedication, but worked quietly and without fanfare to ensure quality health care as an essential responsibility, one that can be looked upon with optimism toward the future and pride and satisfaction for the many accomplishments.

Through its 89 years, St. Mary Medical Center has been not only a health care facility, but a center of cultural diversity in Long Beach as well. This mixture of cultures and beliefs is a source of strength and innovation. St. Mary is a recognized touchstone in the community and has grown not only in size, but also in stature to become a leader in health care that it is today.

The commitment of St. Mary Medical Center to the community of Long Beach reaches back 89 years when the Sisters of Charity of the Incarnate Word bought a private sanitarium and converted it into St. Mary Hospital. Since then, the people of Long Beach have given generously to sustain St. Mary. For its part, St. Mary Medical Center has given hundreds of millions of dollars in charitable medical costs and in unreimbursed care provided through state and federal programs.

Additionally, tens of millions of dollars have been contributed through community services and education. Historically, St. Mary Medical Center also has been one of the top ten employers in Long Beach and a major consumer of services, channeling significant funds back into the local community.

It is this shared commitment among the people of Long Beach and the people of St. Mary Medical Center that has made us each part of the other and together a vibrant community of caring.

Giving Back to the Community

St. Mary Medical Center improves the health of its patients and assists the communities it serves by demonstrating leadership through superior clinical outcomes, quality service, health and healing for the broader community, advocacy and care for those who are poor, and stewardship of financial, human and environmental resources.

St. Mary Medical Center and our sponsors, the Sisters of Charity of the Incarnate Word, are dedicated to providing the Long Beach community with the following:

- **Compassionate, high-quality, affordable health services**
- **Advocating for our sisters and brothers who are poor and disenfranchised**
- **Partnerships with others in the community to improve the quality of life for all**

In 2010 - 2011, St. Mary provided \$36,125,491 of uncompensated services and charity programs to the Long Beach community. This figure includes indigent/charity care, community outreach, community service programs, and community education programs.

St. Mary realizes the needs of the community's underserved are much greater than resources can provide. To that end, and as part of our Commitment to Community, St. Mary also provides direct grants to other 501(c)(3) organizations and sponsors a large variety of fund development projects of many worthy organizations.

Low Vision Center

They come by the thousands. Some are referred by their physicians, but most hear about us from their families, teachers, friends, or neighbors. Still others are just walking by and step through the door. All leave smiling.

Our consultations are free.
Our vision aids and equipment are provided at cost.

Founded in 1976 by ophthalmologist Orville W. Cole, M.D., the Low Vision Center (LVC), is located at 1055 Linden Ave. on the St. Mary campus. The center is funded with private donations and grants by and through the St. Mary Medical Center Foundation and the medical center itself. In FY 2011, the Foundation provided LVC with grants totaling \$220,000, or almost forty percent of the LVC's total operating expenses.

LVC offers approximately 300 different optical aids. They range from hand-held magnifiers to electric video magnifiers that read images laid on a flat surface and magnify them 60 times onto a screen. The center has sixteen of these machines, obtained through grants. More commonplace items are illuminated magnifying glasses, headgear with flip-down magnifiers and clip-on magnifiers that enhance maximum prescription eyeglasses.

LVC has served private and parochial schools since its beginnings, but expanded into the public school system three years ago. It focuses on elementary schools, but high schools are served by special request. A normal day at a school screens between 140 and 360 students.

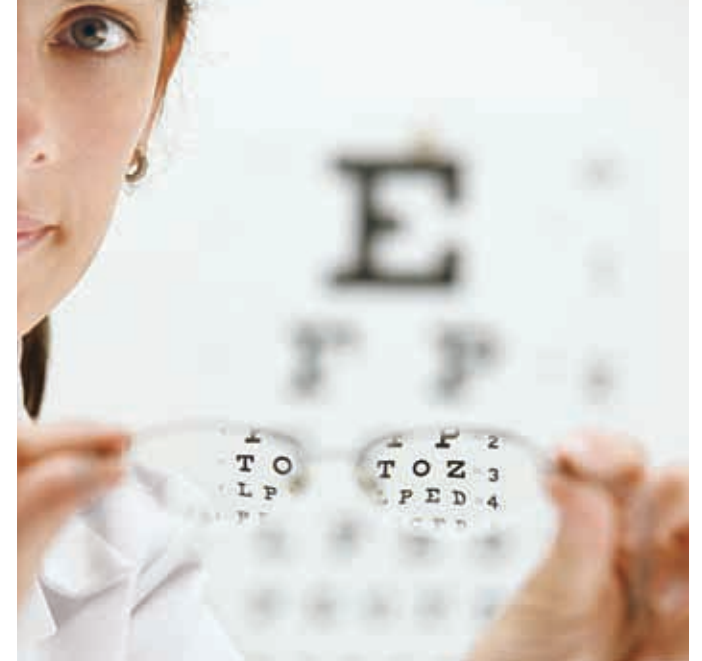
Independent Living Skills lectures and classes – also free – are taught at the center and in various public and private venues in the community. Attendees are taught techniques for daily living, such as cleaning, cooking and labeling skills. Equipment provided includes canes, sewing and handiwork implements, and reading glasses.

LVC programs are also available at health fairs, senior centers and at meetings of both public and private organizations upon request. Even home visits are possible, when needed.

All told, LVC served 6,140 people in our community over the past year, including 4,108 children.

Families in Good Health

In 1987, Families in Good Health (FiGH), was born out of the healthcare needs of people who had escaped almost certain death, people who had arrived in our community with little more than hope to sustain them and community caring to help them rebuild their lives.

For its first decade, our FiGH Program was known as the Southeast Asian Health Project serving primarily refugees from Cambodia with outreach, patient navigation and home visitation services to bridge the culture gap.

By the mid-1990s, this significant minority presence had expanded to include growing Latino and African-American populations and the program morphed into FiGH.

Operating overhead is provided by St. Mary Medical Center, but the majority of funding comes from public and private grants through our Foundation.

Current activities include:

Best Babies Collaborative

FiGH is one of the original partners in the Best Babies Collaborative, a program of community-based groups providing intra-conception care to high-risk women from pre-natal to two years after birth.

Education Providers – Supporting Children (EPSC)

EPSC reaches out into the otherwise unrecognized community of unofficial child-care providers, such as grandparents, friends, neighbors, and siblings, with formal instruction for caring for newborns and children up to age five.

Love Your Heart

Only in its second year, the Love Your Heart program, established in memory of Kellee Murchison Bennett,

provides cardiac screenings focused on the Asian, Latino, and African-American communities. More than 1,800 persons were screened by Love Your Heart in 2011.

Educated Men with Meaningful Messages (EM³)

Formed in 1996, EM³ is a state-funded program that advocates and promotes health equity in all communities of color. Since then, the program has provided guidance and direction to thousands of at-risk multi-ethnic youth.

Healthy Aging for Pacific Asian Seniors (HAPAS)

Part of a federally funded collaborative, HAPAS provides better access to healthcare, medication education and case management within the Laotian community.

Promoting Access to Health (PATH)

A collaborative of Pacific Islander and Southeast Asian servicing agencies, PATH's focus is to increase early screenings for cervical cancer and breast cancer diagnosis and treatment.

Taking Control

Through Taking Control, we offer breast cancer education and patient guidance funded by the Komen Race for the Cure Foundation.

Senior Center



Sometimes in ways few would expect, more than 7,000 men and women, the majority aged 55 up, were directly served by the St. Mary Senior Center in 2010-2011.

The Senior Center is located in a modest, former physicians' office building next to the medical center's major education center across from St. Mary's main entrance. Sandy Bazant is the program's only full-time staff member, but is assisted by almost a dozen hard-working volunteers. Together they coordinate the classes and workshops, as well as free health screenings, low-cost exercise and massage programs. The center offers free computer training/internet access and makes fax and copier services available. Members also receive complimentary hospital parking and transportation.

In 2010-2011, more than sixty-five community education lectures were offered and more than forty-five health and wellness screenings were conducted for seniors. Lectures and screenings attract people outside the immediate St. Mary neighborhood and Long Beach, such as Seal Beach and Los Alamitos.

As people age, navigating through increasingly complex medical issues and opportunities can prove overwhelming. With a membership of almost 12,000 people and a newsletter mailing list that exceeds 22,000, our Senior Health Services reaches out to this growing community to help our aging friends, family and neighbors to continue to lead healthy, productive and confident lives.

Comprehensive AIDS Resource and Education

Much has changed since our CARE program was launched a quarter century ago. What had begun as a few isolated cases of a mysterious and virulent illness among otherwise healthy young gay men had become a seeming torrent of illness and death among gay and straight communities alike.

Misinformation and misunderstanding ran rampant through all segments of society. True to its mission and tradition, St. Mary Medical Center took action to help those in need.

We are immensely proud of the role the St. Mary CARE program has played not only directly among the communities of Long Beach, but by example and replication across America. Today, ours is a non-profit, hospital-based, nationally recognized program providing HIV medical, dental and psychological services to more than 1,500 low income residents of southern Los Angeles County, regardless of their ability to pay.

The severe economic downturn of the past few years has increased the number of people who have lost or given up costly health insurance and cannot afford to pay for our services. In 2011, our lapsed insurance clients increased by thirty percent and our overall case load by twenty percent.

Despite the gains made in public education and attitude over the years, we remain sensitive to our clients privacy; ours is the only HIV-testing clinic in Long Beach that is not clearly identified as an STD (sexually transmitted disease) facility. This facility is completely staffed by Board-Certified Infectious Disease Specialists and highly trained nurses, social workers and other healthcare professionals with insight into the needs of a diverse, multi-ethnic population.

Our CARE Dental Center offers the HIV community two full-time dentists who fill and extract teeth, produce partial and complete dentures, and perform root canals, as well as a full-time hygienist. It is one of very few HIV-specific dental clinics in the United States.

CARE also offers on-site psychiatric counseling, as well as individual and group counseling services, and abuse screenings, as well as referral services to outside providers. In 2011, all of the HIV-positive clients were offered these care linkages, an offer accepted by seventy-five percent of those referred.

Nutritional services are provided by our registered dietician and housing assistance comes through our contract with the City Of Long Beach, which provides two full-time, on-site housing coordinators.

The CARE's Family Services Program (FSP) is wide-ranging and geared to helping the changing HIV/AIDS community in Long Beach and beyond. Its services are available to individuals living with at least one dependent child under 21. The bi-monthly Family Food Bank, for instance, provides fresh meat, produce, and dairy products, as well as packaged staples not just to the infected individual, but the entire family - the only such provider in our area.

The CARE Program in 2010-2011, had visits totaling 198,069 across its services base and anticipates almost a quarter million visits in 2011-2012.



The Hands of St. Mary

Open, outstretched hands can be many things.

They can be an offer of help in times of dire need. They can be grasped softly to welcome new acquaintances or with vigor to greet old friends. They can steady us as we walk along new and uncertain paths. They can rest gently on our shoulders in reassurance that we are not alone.

The clinics of St. Mary are the outstretched hands of our medical center. They reach out into our community in a connection of caring and concern. When a young girl enters the world of womanhood, our OB/GYN Clinic extends a gentle hand. Our Pediatric Clinic offers a confident guide through the mystery and wonders of childhood and the challenges of being a new parent. When life's hard lessons descend upon our community's core or a family member's absence impacts those left behind, our hands reach out from the Family Clinic. And, when life and time change everything, we are there in our Senior Clinic to offer advice, counsel, and medical expertise.

Our clinics, while serving thousands of our neighbors, also usher new patients into the St. Mary Medical Center system of care. They introduce our medical staff, health care professionals, and a myriad of services to individuals and families who might not otherwise know about or benefit from the excellent care St. Mary offers.

The Senior Clinic and the Family Clinic also introduce our graduate medical resident physicians to the community and help them to complete their formal, full-time medical training. As in any valuable and valued relationship, each learns from the other and leaves with something more than they had before.

Simply stated, our clinics are there for the community. They do not always operate in the financial black, but they never want for resources because profit has never been the point. Our clinics exist to help anyone who needs medical assistance and care who, for whatever reason, need not or cannot avail themselves of the services at St. Mary Medical Center. They are truly our outstretched hands of help and hope.

Hospital Highlights

Fact Sheet

St. Mary Medical Center, the only Catholic hospital in Long Beach, is a 389 licensed bed not-for-profit medical center offering diversified and award-winning medical services. St. Mary opened in 1923 as a 70-bed hospital under the sponsorship of the Sisters of Charity of the Incarnate Word. In 1996, St. Mary joined Catholic Healthcare West, the largest non-profit health care system in California, which operates 40 hospitals in California, Arizona and Nevada.

St. Mary serves as the only regional teaching hospital for the UCLA School of Medicine and offers medical students the opportunity to learn from the latest and most advanced techniques available. St. Mary has led the way by being the first in Long Beach with the following: labor & delivery and recovery rooms; private birthing suites; cardiac department; pacemaker implant procedure; trauma center; HIV treatment center; and hospital-based hospice program. In addition, it has the first and only Low Vision Center in the area. St. Mary is also the base hospital for paramedic services in Long Beach, and the designated Disaster Resource Center for Long Beach and southern L. A. County.

St. Mary has also made its mark nationally as the nation's first hospital to fully integrate Patient-Focused Care, the nation's first managed care network for HIV-positive patients and one of only eight hospitals to participate in the pilot of the latest treatments of breast cancer.

Principal Services:

- Comprehensive Cancer Center offering state-of-the-art protocols in chemotherapy, radiation oncology and surgery. St. Mary provides patients the latest medications and treatment techniques, including chemotherapy, immunotherapy, biologic response modifiers, nutritional interventions and new anti-nausea agents.
- The Cardiac Center at St. Mary provides comprehensive cardiac services including innovative techniques such as coronary stents, electrophysiology studies, ablations, and coronary arterial bypass surgery.
- The SurgiCenter at St. Mary is Long Beach's only freestanding, hospital-based outpatient surgery center.
- 24-hour Emergency Services and a Level II Trauma Center, with a base station for LA County Mobile Intensive Care squads and has a helipad for emergency air transport.
- The Rehabilitation Institute offers physical and occupational therapies, and speech pathology.
- Passages Outpatient Program includes geriatric assessments, outpatient geropsychiatric treatment, support groups, and rehabilitation.
- Maternal & Child Health department had a banner year in 2010 delivering 3,022 babies, and is on track to deliver over 3,000 this year. The department includes Labor & Delivery, Post Partum and Level II Neo-natal Intensive Care Unit.
- Bariatric Surgery Center offers treatment to patients struggling with obesity-related issues, and is a Center of Excellence as approved by the American Society of Metabolic & Bariatric Surgeons.
- Disaster Resource Center at St. Mary is the designated regional center for disaster preparedness in the event of a major catastrophe for eleven hospitals and medical centers in the greater Long Beach and southern Los Angeles County area.

Her affiliation with St. Mary Medical Center began as a member of the Guild. Her volunteer efforts continued through working with seniors at her church, retirement homes, and convalescent hospitals. She derived great pleasure in her role as a Eucharistic minister at these facilities.

Kathleen is a very giving person and in addition to her charitable contributions, each year she purchases and distributes hundreds of loaves of bread during the holidays in support of a Catholic charity in Los Angeles.

Kathleen's support of St. Mary has been frequent and significant. St. Mary is the beneficiary of three charitable remainder trusts, a charitable gift annuity, and is included as a beneficiary of her estate. In addition, Kathleen is a generous benefactor of her church, many Catholic charities, and Thomas Aquinas College in Ojai.

In honor of Kathleen's benevolence, one of the major conference rooms in the John Edward Parr Health Enhancement Center has been designated the Burke Room. To paraphrase the Irish Blessing, *"God holds Kathleen in the palm of His hand."*

Audited Financials

The St. Mary Medical Center Foundation is an independent non-profit 501(c)(3) corporation that exists for the sole purpose of developing resources for St. Mary Medical Center. Contributions to the St. Mary Medical Center Foundation are tax deductible.

Income figures in the financial statement above show net income of \$4,820,937 million from fundraising sources. During the fiscal year (July 1, 2010 - June 30, 2011) the Foundation generated \$5,189,834 million in gross income from various organized fundraising programs, including special events, campaign pledges and bequests from the groups of donors listed in the chart on the next page. These should not agree with the net income statement above. The number of donors in 2011 was 2,590.

In fiscal year 2011 (July 1, 2010 – June 30, 2011), the Foundation raised net revenue of \$4,820,937 in gifts, grants and bequests from a total of 3,823 gifts. (See audited figures in the chart on the previous page). The number of donors and the gross revenue from donor constituencies are listed below.

Gifts received for unrestricted purposes were generated by the Foundation’s Annual Fund and by other unrestricted gifts and bequests. For restricted purposes, gifts came from a variety of constituent groups and sources – Major Gifts from individuals and corporations, Public and Private Grants from government agencies and private Foundations, and Estate Planned Gifts from individuals.

Lou Cassani, Chair of the Fund Development Committee of the Foundation Board of Trustees, once again monitored the fund raising performance of the Foundation in 2011 for the Board.

Grants approved for St. Mary Medical Center

Under the leadership of Dave Shlemmer, Chair of the Grants Committee, the St. Mary Foundation awarded \$3.8 million for the year, approving \$4.6 million in new grants to St. Mary in the year ending June 30, 2011.

The Grants Committee approved a total of \$3.1 million in new grants for programs and services, continuing its commitments for St. Mary’s Community Outreach Programs, many of which were started by the Sisters of Charity to improve the quality of life for the residents of Long Beach. These programs include the Low Vision Center, the Families in Good Health Program, and the C.A.R.E. Program.

Grants were also made to support innovative programs to meet recent hospital and community needs, such as the Palliative Care Program, the Munzer Nurse Scholar Program, and the Clinical Care Extender Program for young interns volunteering at St. Mary.

The Committee also approved new grants totaling \$1.4 million for capital needs including \$350,000 for hospital signage, \$250,000 for the Labor & Delivery renovation, \$170,000 for equipment in Obstetrics & Gynecology.

The Foundation has awarded the hospital \$46 million in grants in the past ten years. (See chart below).

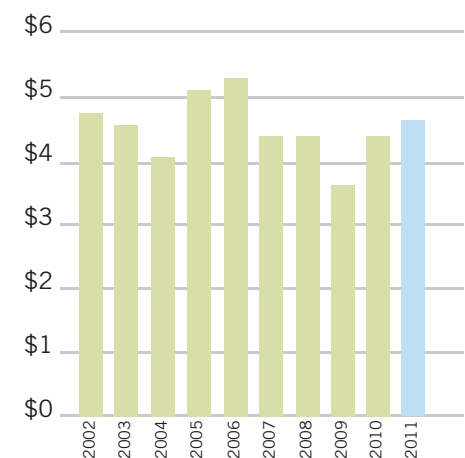


Investment Income

For the fiscal year ended June 30, 2011, the Foundation showed a net gain in its investment portfolio of \$3,046,437 million, including realized and unrealized gains and losses. The Foundation’s portfolio performed nicely in 2011 with a 16% return.

This was the eighth full year of investment oversight by Beacon Pointe Advisors who were hired in 2003 to oversee the management of Foundation assets. Beacon Pointe, under the supervision of the Foundation Investment Committee, which is chaired by Bob Fronke, former Long Beach City Auditor, monitored the following firms who managed the various asset groups of the portfolio in 2011: Knightsbridge Asset Management, St. James, Stralem & Co., Saratoga and Vaughn Nelson (Domestic Equity Managers), Dodge & Cox and Lazard (International Equity Managers), PIMCO (Domestic Fixed Income Manager), Templeton International Fixed Income, E.I.I. (Real Estate), and Hatteras, PIMCO Commodity and R.S. Natural Resources (Special Alternative Investment Managers). The CHW Philanthropic Fund and Farmers & Merchants Bank added to the portfolio’s diversity.

Foundation Grants 2011

St. Mary Medical Center Foundation Grants

The mission of the St. Mary Foundation is to provide funds to St. Mary Medical Center for programs, service, education, capital improvements and equipment. The Foundation was established in 1970 by the Sisters of Charity of the Incarnate Word specifically for this purpose. Each year the Grants Committee of the Foundation recommends grants for projects requested by the medical center, and in Fiscal Year 2011 (7/1/10 - 6/30/11) the Foundation's Executive Committee approved \$4,558,086 for programs, service, capital improvements, equipment, and education.

Programs and Services **\$3,125,391**

C.A.R.E. Program **\$679,854**

Provides comprehensive HIV/AIDS services to the greater Long Beach Community. A federally supported grant to conduct research into viable technological information for AIDS patients and treatment protocols.

C.A.R.E. Program **\$252,172**

This grant covers the costs of care for those patients who do not have adequate insurance or financial resources. Also provides funding for the C.A.R.E. Food Bank, C.A.R.E. Women's Services, and the C.A.R.E. Family Fund.

COPE Program **\$150,000**

The Community Outreach for Prevention and Education program provides internships at St. Mary to students interested in health-related careers.

Emergency Medication Program **\$9,058**

Utilizing funds provided by the Employees Community Fund of Boeing California, addresses the needs of the uninsured and underinsured, who cannot afford to pay for their medication.

Hospital Departments & Services **\$673,058**

These grants include funding for an Emergency Room Resident, a Geriatrics Symposium, the Employee Assistance Program, a patient emergency medicine program, and much needed equipment throughout the hospital.

Families in Good Health (FiGH) **\$650,000**

The FiGH Program individuals, families and communities with education, screenings, and health care services, with sensitivity to the language and cultural needs of the Asian, African-American and Hispanic communities, enabling them to make well informed and appropriate decisions about their health.

Low Vision Center **\$185,000**

Free vision testing and comprehensive visual rehabilitation are provided for those in need. Services include instruction in Braille, provision of optical aids, vision screening in local schools and independent living skills classes for seniors.

Munzer Nurse Scholars **\$25,000**

Provides scholarships to nursing students in the Long Beach Community College Administration Program. Includes tuition, books, uniforms and other program costs.

Palliative Care **\$472,421**

Provides operational support for a comprehensive Palliative Care and pain management program for our patients and as a support for our physician partners.

Peck Family Vision Program **\$28,828**

Provides free comprehensive eye exams and glasses for any child in the Long Beach Unified School District whose family is unable to afford it.

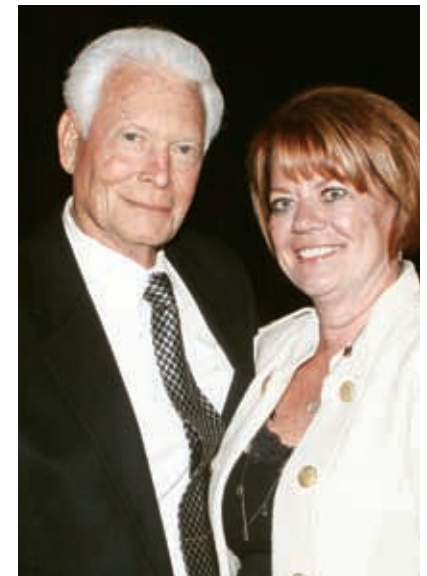
